1. Only an approved spanner wrench shall be used to operate any fire hydrant. Any other type of wrench is strictly forbidden. Hydrants must be opened and closed slowly with an approved fire hydrant wrench. Please call CHWD @ (916) 725-6873 if you have any questions or concerns.
2. The permit must, at all times, be carried in the vehicle drawing water for inspection by the Water Purveyor, Fire Department, and Sheriff or Police Department.
3. The permittee shall, by acceptance and use of this permit, be responsible for any damage to a fire hydrant or appurtenances, as a result of the use herein authorized, shall be held responsible for the costs of its repairs, and agree to pay such costs as soon as the amount thereof is authorized.
